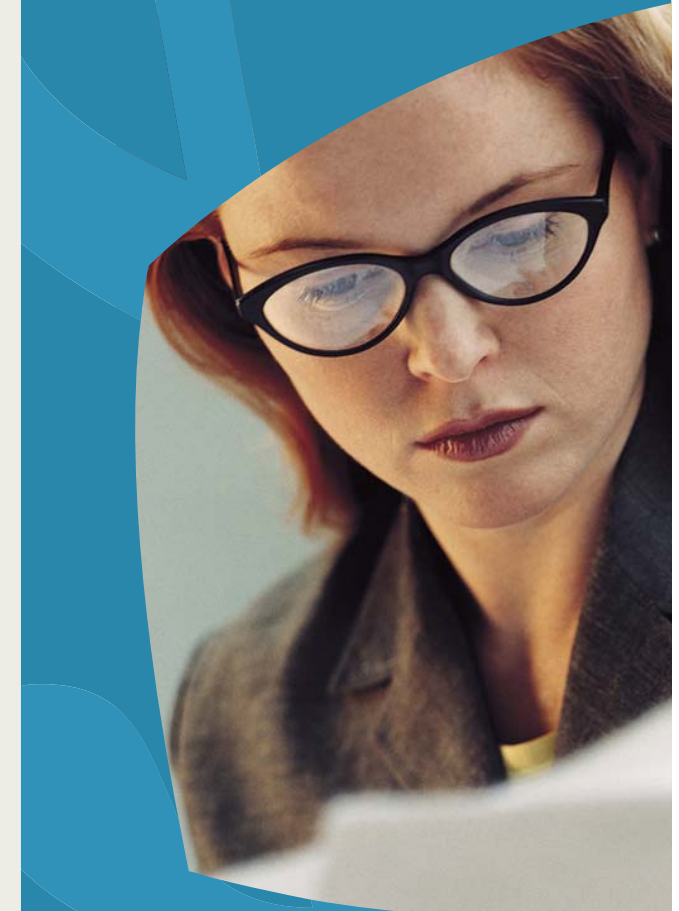

To obtain a real estate salesperson's license in Virginia, an individual must be at least 18 years of age, a high school graduate or equivalent, successfully complete a 60-hour course in the Principles and Practices of Real Estate, pass a state exam and become affiliated with a real estate broker in Virginia.

Registration: All fees must be prepaid. Registrations will not be processed if the correct payment amount is not submitted. **All fees must be paid two weeks prior to class date.**

Attendance Policy: Class will begin promptly at the time noted. Late arrivals will not be admitted to class.
